RE: Children's Safety and Welfare, Update on crime reference number: 6029679/21

Dear ....

Following my recent communication with you, I must now update you on the Metropolitan Police assessment of the allegations related to the UK Covid-19 vaccine programme.

On the 22nd February the UK Metropolitan Police dismissed the evidence that the legal team Philip Hyland and Lois Bayliss, alongside Mark Sexton, Dr Samuel White and the people of Britain, had been submitting under crime reference number: 6029679/21.

This was a monumental failure in the UK justice system that will go down in history. The evidence was clear and indisputable. As you would have seen with the evidence sent to you previously, there has been a shocking amount of harm and death in the UK alone which has been caused by the Covid-19 vaccines.

I refer you back to the significant amount of adverse reactions caused by the Covid-19 vaccines which have been recorded, so far, on the MHRA Yellowcard Scheme and accessed via the government website.

Up to 16 February 2022... "The MHRA has received 3,111 UK reports of suspected ADRs for the COVID-19 Pfizer/BioNTech Vaccine in which the individual was reported to be under 18 years old, 254 reports for the COVID-19 Vaccine AstraZeneca, 21 for the COVID-19 Vaccine Moderna and 19 where the brand of vaccine was unspecified."

"The MHRA has received 720 UK reports of suspected ADRs to the COVID-19 Pfizer/BioNTech Vaccine in which the patient died shortly after vaccination, 1,225 reports for the COVID-19 Vaccine AstraZeneca, 38 for the COVID-19 Vaccine Moderna and 39 where the brand of vaccine was unspecified."

A line in the sand has been drawn. Every month the Yellowcard statistics increase. The evidence provided to the Metropolitan Police is substantial and they are now guilty of obstructing justice.

When the evidence was submitted to the Metropolitan Police by the legal team Philip Hyland and Lois Bayliss, alongside Mark Sexton (retired police constable) and Dr Samuel White the worry was simple: so much impervious and sometimes complex evidence had been submitted that the police might delay the needed injunction for months as they investigated the evidence. To give an idea of the scale of the evidence there were 200 witness statements of vaccine injuries along with 1,500 scientific studies of the Covid vaccine lethality.

In the time between the submission and the Metropolitan Police statement, there was not enough time to review these cases, let alone the hundreds of complex science reports and the data analysis submitted by some of the most qualified and trusted experts of Britain and abroad including Dr Mike Yeadon (Former vice-president of respiratory research division, Pfizer).

On 24th February, a panel of British professors, doctors and medical experts from the Children's Covid Vaccine Advisory Group (CCVAG) presented new evidence to journalists about the unfavourable risk-benefit balance of the Pfizer Covid-19 Vaccine for children. On the panel were Dr Ros Jones a retired paediatrician, Professor David Livermore who is a Professor of Medical Microbiology at East Anglia University and former Director of Antibiotic Resistance Monitoring for Public Health England. Along with Dr Clare Craig a Diagnostic Pathologist, Dr Elizabeth Evans Director of the UK Medical Freedom Alliance and Professor Angus Dalglish Professor of oncology at St George's. The audience also heard from Maxwell Harrison, a vaccine injured young person.

"....I am instructed by Doctor Sam White to request that you review your decision to take no further action in relation to the above crime reference number [CRN].

The letter is an open letter given the public interest in the issues raised as well as the need for transparency.

The Complainants have 80 years of unblemished regulated service in regulated professions.

Since reporting the crimes and obtaining a CRN, the Complainants have had untrue statements made about them in the mainstream media. All Complainants have reason to believe that their personal safety is under threat.

All Complainants have reason to believe that concerted attempts are being made to undermine and denigrate the messengers rather than deal with the....."

There are concerned parents and families within your school. They know you have been in receipt of this information. If the Covid vaccinations take place on your school premises and any suspicious injuries or deaths occur, individuals will bear witness that you have been pre-warned about the dangers and potentially lethal Covid-19 vaccine and submit it to investigation.
